Board president David M. C. Stern, vice-president Anish Nanavaty, Board members, David Chao, Jennifer Darger, Jonathan Faust, and Brian Yarrington were present. Superintendent Victoria S. Kniewel and Assistant Superintendent Susan Shirken, District Clerk Rosemary DeVito, Jennifer Allen, Michael Curtin, Devan Ganeshananthan, Ed Kennedy, and Joseph Schippa also attended. Board member Michael Bianchi was unable to attend. There were 18 community members present.

I. CALL TO ORDER

Board president David M. C. Stern called the meeting to order at 7:01 P.M.

At 7:01 P.M. Brian Yarrington made a motion to adjourn the public meeting and to begin Executive Session to discuss special education students, personnel, legal matters, and negotiations. Anish Nanavaty seconded the motion and the motion was approved unanimously.

At 8:15 P.M. Jonathan Faust made a motion to readjourn to public session. Anish Nanavaty seconded the motion and the motion was approved unanimously.

II. APPROVAL OF MINUTES OF MEETING

Jonathan Faust made a motion to approve the regular meeting minutes for November 10, 2015 as amended. Jennifer Darger seconded the motion and the motion was approved unanimously.

VI. SUPERINTENDENT'S REPORT

(1) Update on Literacy Initiatives

Michael Curtin

Victoria called upon Michael Curtin to talk about the different literacy initiatives being discussed in the district over the past two years. Using PowerPoint, Mike addressed four specific areas: Expanded Reading Committee, Writing Practice Program, Instructional Support for Struggling Edgemont High School Readers, and Kindergarten Literacy.

Mike explained that teachers of various grade levels and content areas have been working hard over the last year to investigate and implement best practices in reading and writing instruction to meet the needs of Edgemont students.

Mike invited Marisa Ferrara and Jessica Leonard, elementary reading teachers, to give the Board and the community a more in-depth overview of the Fountas and Pinnell assessment system. Jessica talked about how this system is helpful in assessing students who are referred for developmental reading. Marisa added that Fountas and Pinnell assessment helps teachers to make informed decisions in planning effective instruction and in identifying those children who need additional support. Mike thanked Arielle Landeck, Reading Teacher at Greenville Elementary School and Deborah Tashjian, Reading Teacher at Seely Place School, for being instrumental in deciding to pilot a broader use of the Fountas and Pinnell assessments.

Mike concluded his report by saying that this assessment is meant to complement and not to replace feedback that can be offered by a teacher, and he reiterated that the goal is to move toward more common assessments and a more consistent approach to teaching literacy. Mike said progress will be shared with the Board at a future meeting.

A question and answer period ensued among the board. Some topics included alignment in the elementary schools, development of new curriculum, group decision making, student writing folders, the need for professional development, and external influences (critical friends).

David M. C. Stern said that his favorite board meetings occur when there is discussion about curriculum development. Mike received a round of applause for his report.

(2) Facilities Planning: Change Order Policy Third Reading

Victoria Kniewel

Victoria Kniewel said that the Change Order Policy is one of three policies that are undergoing review. The policy was first presented on October 27, 2015 with a second reading on November 10, 2015. Tonight will constitute the third reading.

Victoria read the policy with the proposed changes and stated that the policy's intent is to assist when unforeseen circumstances arise while projects are in progress and board meetings are not imminent by allowing the Superintendent the ability to approve such Change Orders. A discussion ensued among board members. Further language clarification was the consensus of the board. David M. C. Stern said that suggested wording for this policy be emailed to Victoria.
