s. **RESOLVED**, that the Board of Education approve the following Agreement between Port Chester – Rye Union Free School District and Blind Brook-Rye Union Free School District for the 2014-2015 school year as noted below.

Agreement made this 1<sup>st</sup> day of July, 2014, by and between the Port Chester-Rye Union Free School District (Port Chester) and the Blind Brook-Rye Union Free School District (Blind Brook).

WHEREAS, Port Chester and Blind Brook transport resident students to the same locations, and

WHEREAS, Port Chester and Blind Brook desire to operate in a cost effective and efficient manner,

**AND NOW, THEREFORE**, it is agreed that Port Chester and Blind Brook agree to cooperatively bid certain transportation routes which are determined to be mutually beneficial to both districts in accordance with the terms below:

- 1. Bid specifications will clearly state the intention of both districts seeking cooperative services.
- 2. Bid specifications will be in keeping with the requirements of the State Education Department.
- 3. Bids will be awarded to the lowest responsible bidder as a "cooperative bid" by each district.
- 4. Each district will enter into one contract for any transportation services/locations reasonably anticipated during the term of the contract. The cumulative amount of both contracts will equal the bid amount.
- 5. Each district may seek an extension of the term of a contract based upon the cooperative bid, but may only extend with respect to those vendors party to the contract.
- 6. District contract /extension cost allocation will be proportional based on the anticipated individual district ridership for the first day school is in session each year of the contract/extension.
- 7. Riders may be added or deleted to a route, however, the initial contract /extension cost allocation will remain in place for the duration of the contract.
- 8. Additional costs associated with Individualized Educational Program needs for additional student services such as, but not limited to, bus monitor, school nurse, wheelchair vehicle etc. will be borne entirely by the individual district in which the student resides.

- 9. In instances where both districts have the same additional student services, cost allocation will be proportional based on the anticipated individual district ridership for the first day school is in session each year of the contract/extension.
- 10. In instances where a wheelchair vehicle is required by only one of the districts, that district will pay 100% of incremental cost for the wheelchair vehicle as compared to a regular vehicle as provided for in the bid response.
- 11. In instances where one district requires additional student services after the initial cost allocation were established AND the additional student service is already in place for the other district, cost allocation for that service will be recalculated proportionally. The district requiring the additional service will submit a new contract for that service to the State Education Department base on the determined cost allocation.
- 12. In instances where one district terminates additional student services after the initial cost allocation was established, cost allocations MAY be recalculated ONLY if re-calculation is in keeping with SED approved contracts for both contracts.
