Dr. Carlisle is preparing his **30/60/90 day entrance plan**. He will also be attending the 2015 Administrators' Leadership Conference this July.

The Long Lake Parks and Recreation Department thanked the school and custodians for hosting the **Quilt Camp**.

We have received a **\$6,500 Bullet Aid Grant** for the 2015-16 school year as noted by Senator Hugh Farley. Dr. Carlisle is looking at working with a grant writer to increase funds for the school.

Salary is per the salary schedule contained in the 7/1/13 – 6/30/18 collective bargaining agreement with the Long Lake Faculty Association.
