VI. DISCUSSION

A. Presentation by Durham Transportation

School Board Members spoke to Durham Transportation during the National School Board Association's Annual Conference in April 2016. Mr. Stevenson invited Keith Galloway to the school division to provide more information to the division about what services Durham Transportation could offer.

Mr. Galloway gave the School Board an overview of transportation services Durham Transportation could offer to the division if outsourced. Reasons for outsourcing include capital expense of owning/maintaining buses, shortages of drivers (the shortage of drivers is across the country, not just locally), drug testing, and wages, which would provide a savings to the school division. Durham Transportation will do a cost analysis/study of our needs and report back to the Board if outsourcing would be a cost savings to the division. Speaking to Durham Transportation does not mean the division will outsource, it is only looking at options for cost savings, if any, and a solution to driver shortages.

B. 2015-16 Budget Review

Mrs. Williams provided the School Board with a Projected Fund Balance Report for year end by fund categories (General Fund, Federal Grants-Title 1, Textbooks, and Food Services). Ray Watson will provide the Board with funding by categories at the August 8, 2016 meeting. During the October 15, 2015 meeting, the School Board approved \$644,190 + \$97,519 Supplemental Appropriation but it was not presented to the Board of Supervisors for approval. Betsy Drewry will add this item to the next Board of Supervisors meeting on August 9, 2016 for approval.

C. School Safety [added to the agenda]

The school division is currently preparing a safety grant for consideration of grant funds. During the NSBA Conference in April, Board members spoke to many vendors about classroom lockdown devices. There were many devices demonstrated at the conference: electronic doors, wedge-type devices, devices attached to the floor, bar system behind doors, etc. The division has done an excellent job taking security measures at the building entrances, but we need to look at the interior doors if a perpetrator entered the building. Mr. Foster provided information to Ron Rhodes that was collected during the NSBA conference to look at a lockdown device that is affordable, user friendly, and self-defense uses. Mr. Foster also asked staff to provide the Board with job descriptions and responsibilities of the School Safety Officers in the schools.

VII. ACTION ITEMS

A. 2016-17 Tuition Rates

Pursuant to Policy JEC, contracted Prince George County School Board full-time employees who do not reside in Prince George County are permitted to enroll their children in the school division on a tuition basis. Tuition charges must be reviewed annually.

Mr. Ashcraft made a motion to approve the rate of \$1,512.00 for regular education tuition and \$3,023.00 for special education tuition. Mr. Franklin seconded the motion.
