JOINTLY DEVELOPED

<u>North Tattnall Middle School</u> will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

Parents are jointly involved in the planning, review, and improvement of the Title I Parent and Family Engagement Policy and the Schoolwide Plan annually. North Tattnall Middle School conducts an annual parent survey each year in the spring to gain input from parents on all parts of the parent and family engagement programming, including the parent and family engagement policy. ANNUAL TITLE I MEETING

<u>North Tattnall Middle School</u> will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent compact.

North Tattnall Middle School believes that parent and family engagement is the participation of families in regular two-way and meaningful communication. The school will communicate with parents in multiple ways during the year through three PTO meetings, parent data meetings, quarterly school council meetings, orientation/Open House event, Annual Title I meeting, monthly newsletters, school emails, automated attendance notification system, personal telephone calls, written notes/letters/notices, flyers/brochures/invitations, student agendas, parent-teacher conferences, parent portal, school messenger, school's website, school's marquee, school's social media (Facebook), Remind 101, 504/IEP/TPC/ESOL/PAC meetings, and academic events. The school counselor serves as a resource for parents to obtain literature on hygiene, bullying nutrition, and other pertinent topics. The school nurse provides resources to families on medical, dental, and vision needs. North Tattnall Middle School coordinates and provides an orientation and experience at the school for rising sixth graders in the spring from the elementary school. A sixth grade orientation for parents and students is held in July before school begins. North Tattnall Middle School offers support for rising ninth graders and parents as they begin registering for classes and transitioning to the high school in the spring of their eight grade year.

North Tattnall Middle School provides parents with a description and explanation of the curriculum and assessments in use at the school as well as individual student academic assessment results and interpretation of the results, Title I, Part A requirements, and parent materials and training to support their child's academic progress through multiple participation opportunities. These opportunities include parent and teacher conferences, RtI/504/IEP parent meetings, Open House in July 2023, Annual Title I Parent Meeting in August 2023, Night of Thanks and Giving in November 2023, Batting for Books in March 2024, parent resource center, and transition (Elementary/Middle and Middle/High) meetings. North Tattnall Middle School also provides opportunities for the participation of parents with limited English proficiency. ESOL teachers is available to assist students and parents with limited English proficiency. Individual academic assessments and the interpretation of the results will be interpreted for parents in a language they can understand through the assistance of the ESOL teacher and translator/translation device-services as needed. The school also has a Migrant Student Service Provider (SSP).

BUILDING CAPACITY OF SCHOOL STAFF

North Tattnall Middle School will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:
