- \* In order to be granted tenure, a classroom teacher must receive composite or overall annual professional performance review ratings pursuant to Education Law §3012-c and/or §3012-d of either effective or highly effective in at least 3 of the 4 preceding years. Further, if the classroom teacher receives an ineffective composite or overall rating in the final year of the probationary period he/she shall not be eligible for tenure at that time, in which case the Board of Education, in its discretion, may extend the teacher's probationary term for an additional year.
- 28. A Maternity Leave of Absence be granted to Alicia Cammillieri, as Elementary Teacher at Edison School, beginning August 31, 2015 through approximately November 20, 2015. WHEREAS, the Port Chester-Rye Union Free School District ("the District") is considering the impact on the environment in accordance with the New York State Environmental Quality Review Act and its implementing regulations 6 N.Y.C.R.R. 617.1 et.seq ("SEQRA") of a proposed capital improvement project known as the Port Chester Middle School 5th Grade Addition and High School Addition (hereinafter "the Project") which is set forth in more detail in the two Full Environmental Assessment Forms Part 1 with attached drawings located at the District administrative offices ("the Project Plan"). The Project is to be undertaken at:

The Port Chester Middle School located on 113 Bowman Avenue in Rye Brook, NY 10570. To accommodate relocation of the 5th grade to the Middle School from four district elementary schools, a ±41,080 square feet of gross floor area 5th grade addition is proposed at the rear of the Middle School along with additional parent and teacher parking, traffic circulation improvements, and improved ingress and egress. A drop-off/pick-up area is proposed adjacent to the 5th grade addition. The 5th grade addition includes 15 classrooms, an art room, music room, gym with locker room, a separate cafeteria, and a 5th grade media center, and;

The Port Chester High School located on 1 Tamarack Road, Port Chester, NY 10573. Proposed is a 2-level ±59,483 gross square feet of floor area building addition to the east side of the existing Port Chester High School building, which will be stepped into the ground to reduce its visual impact on the existing High School building. Proposed are 11 new academic classrooms, 3 new science rooms, new digital art and technology spaces, a championship size gym to replace the existing gym constructed in 1929, full size band and choral rooms, and a rooftop educational area on top of the addition. Other proposed work includes an all-season synthetic turf field to replace the existing field, a secure courtyard, new bleachers, relocation of the memorial plaza and memorial bricks, and a redesigned flag plaza, all on the east side of the building adjacent to the proposed addition.

WHEREAS, the District directs that the District consultants notify as appropriate involved and interested agencies under SEQRA of the District's intent to act as lead agency for the coordinated environmental review of the Project under SEQRA to such agencies (list attached) together with this Resolution of the District's intent to act as lead agency for the SEQRA review of same, and if no objection to the District acting as lead agency is upheld in accordance with applicable law, then the District wishes to be installed as lead agency in order to conduct a coordinated environmental review under SEQRA for the Project;

**BE IT RESOLVED**, that the District hereby directs District consultants to provide the involved agencies and interested agencies for the Project (list attached) with a copy of the EAF Part 1 for the Port Chester Middle School 5th grade addition and the High School addition and a copy of this Resolution, that the District intends to act as the lead agency in order to conduct a coordinated environmental review for the Project under the New York State Environmental Quality Review Act; and

**BE IT RESOLVED**, that if no objection to the District acting as lead agency is received within thirty (30) calendar days, then the District will declare itself as lead agency for the SEQRA review of the Project and conduct a coordinated environmental review for same in accordance with 6 NYCRR. 617.1 et seq. of the implementing regulations under the New York State Environmental Quality Review Act as well as Article 8 of the New York Environmental Conservation Law, and

This resolution shall be effective immediately.

**D. WHEREAS,** the NYSSBA actively supports legislation which would require the design & validation of an APPR process that truly informs instruction and thereby promotes student learning.

**WHEREAS**, the Annual Professional Performance Review (APPR) process was first introduced to the public schools in New York in 2000 and was initially designed to help improve professional practice and enhance student growth/achievement; and,

**WHEREAS,** there have been recent attempts to articulate rubrics to better operationalize the scope and sequence of effective teaching practice within the precepts of Marzano, and Danielson and other experts; and,

**WHEREAS**, the algorithm developed by the SED is at best an educated hypothesis to quantify the relationship of teaching to student achievement and one that has yet to be adequately tested and validated; and,

**WHEREAS**, there have been significant issues raised by teachers, administrators, the Regents, the Legislature and Boards of Education; and,

**WHEREAS**, the Governor of the great state of New York sought to sidestep these concerns and instead use the budgetary process to push through a new round of implementation of APPR; and,

WHEREAS, at the recently convened "Learning Summit" the only agreement reached among the experts present was that there is no agreement at this time regarding the efficacy of the so-called "Value-Added-Model" (VAM) and in fact there was noticeable concern raised about the amount of error associated with this model; and,

**WHEREAS**, we do not yet have an APPR model that has been duly-validated as a means for informing instruction and supporting student learning, nor do we have a validated tool for assisting us in supporting the professional development of teachers or making critical personnel decisions; and,

**THEREFORE,** be it resolved that the Port Chester-Rye Board of Education recommends that a two-year moratorium be created for the implementation of APPR, that an expert panel be created that balances both technical & practical expertise to give guidance to this APPR process, and that a scientifically-defensible validation procedure be conducted.

Upon motion by Mrs. Brakewood and seconded by Mrs. Capeci, items A-P of the consent agenda passed unanimously.
