SUPERINTENDENT'S REPORT

- On November 18th through November 20st, I attended the Triple I Conference in Chicago, along with many others in our district. It was very nice to attend this annual event. Sessions and events that I attended, included: 10 Things I Hate About Bargaining: Tips to Love the Process, Opening the Door of Opportunity for McKinney-Vento Families which our team did a wonderful job presenting, and the carousel of panels on The Power of Planning, and I circulated throughout the room visiting other panels. One of the busiest panels was the session with the therapy dog. In addition, I spent some time in the Exhibit hall and hospitality events.
- We continue to meet as an administrative team developing and implementing plans and strategies to address our targeted status for improving in the areas of academics and attendance. We're incorporating these into our District Improvement Plan, School Improvement Plans, creating attendance teams at each school, identifying students with attendance concerns before they chronically absent (out 10% of days or more), and implementing daily attendance tracking sheets on an individual student level. For academics, we use the heart of the PLC process, that being a guaranteed and viable curriculum (for all students) aligned with the IL state learning standards, common formative assessments (benchmark assessments), and interventions for students that are struggling and activities to extend the learning for our advanced students. SCISC was approved as a provider to partner with on our targeted status. Many of us will be attending a workshop at SCISC with them on Monday.
- Principal observations continue, these have been informative to see their professional practice. It's
 great getting into our school buildings, visiting with students and staff members. Everything we've
 done is in complete compliance with the Illinois PERA law for evaluating Principals and Associate
 Principals.
- As a district, we continue to monitor student and staff attendance and wellness; especially the cases
 of Covid, influenza, and RSV that we're informed of. We're doing well as a district and in community.
- As we get closer to our holiday break, it has been wonderful to attend and support all of the events
 with staff, students, and community members. These have included musicals (at all grade levels),
 band concerts, choir concerts, our family painting night, our EL celebration, senior dinner, and our
 annual district holiday party. It's great to see everyone together smiling and laughing, and all of the
 amazing talent by our students performing and being led by our teachers.
