Dear Parent/Guardian,

North Tattnall Middle School, students participating in the Title I, Part A program, and their families, agree that this compact outlines how the parents, the entire school staff, and the students will share the responsibility for improved student academic achievement as well as describes how school and parents will build and develop a partnership that will help children achieve the State's high standards.

### JOINTLY DEVELOPED

The parents, students, and staff of NT Middle School partnered together to develop this school-parent compact for achievement. Teachers suggested home learning strategies, parents added input about the types of support they needed, and students told us what would help them learn. Parents are encouraged to attend annual revision meetings held during the fall each year to review the compact and make suggestions based on student needs and school improvement goals. Parents are also encouraged to participate in the annual Title I parent survey that is also used as a tool to collect parent feedback regarding the current Title I programs and policies.

To understand how working together can benefit your child, it is first important to understand the district's and school's goals for student academic achievement.

#### **Tattnall County School District's GOALS:**

More individualized and small group instruction will be implemented in order to meet the needs of ALL learners to show a 3% increase in the total percentage of students earning levels 2, 3, and 4 on the Spring 2024 GMAS (EOG and EOC) for all content areas.

Tattnall County will decrease the percentage of office discipline referrals (ODR) of the top 10% of referred students from 33% in 2022-2023 to 30% of all referrals in the 2023-2024 school year.

The district will seek to employ professionally qualified teachers and increase the retention rate by 3% (excluding retiring employees) in 2023-2024.

# North Tattnall Middle School's GOALS:

North Tattnall Middle School will *decrease* the percentage of students scoring in the Beginning Learner level in **ELA** from 34% to </= 28% and increase students scoring in the Distinguished Learner level from 5% to >/=9% in grades 6-8

North Tattnall Middle School will decrease the percentage of students scoring in the Beginning Learner level in **Math** from 22% to </= 19% and *increase* students scoring in the Distinguished Learner level from 8% to >10% in grades 6-

North Tattnall Middle School will decrease the percentage of students scoring in the Beginning Learner level in **Social Studies** from 22% to </=19% and *increase* students scoring in the Distinguished Learner level from 9% to >/=10% in grades 6-8.

North Tattnall Middle School will decrease the percentage of students scoring in the Beginning Learner level in **Science** from 46% to < 30% and *increase* students scoring in the Distinguished Learner level from 5% to >/=9% in grades 6-8.

Increase school connectedness to > 80% on the Spring 2024 Georgia Student Health Survey
