JOINTLY DEVELOPED

<u>South Tattnall Elementary School</u> will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

Parent and family engagement and community support are critical to the education of our students at South Tattnall Elementary School. A continuous effort will be made to solicit input and involvement from parents, families, and community members. Parent and teacher surveys are conducted in April of each school year. The following strategies were outlined.

I. The school distributes them prior to November 1 and they are available online on the school website, https://stes.tattnallschools.org/, as well as copies being available upon request.

ANNUAL TITLE I MEETING

South Tattnall Elementary School will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent compact.

An annual review of the Title I program at South Tattnall Elementary School is held in the fall of the year at a convenient time prior to November 1 (October 19, 2023). All parents and families are invited and encouraged to attend where Title I information and the parents' rights under Title I is shared with them. The Annual Title I Parent meeting will be posted on the school marquee, school website, school social media, Class Dojo, as well as flyers sent home to families. A sign in sheet with roles, agenda, presentation and minutes will be kept by the Academic Coach as evidence of the meeting. COMMUNICATIONS

South Tattnall Elementary School strives to have a positive relationship with open communication with families. The school will communicate with parents in multiple ways throughout the school year.

Parent conferences are encouraged to foster parent engagement in the education of their child. The school will communicate with parents about school and parent programs, meetings, and other activities/events in a format, to the extent practicable, and in a language that parents can understand through the school website, Class Dojo, social media, school marquee, Parent Portal, student communication folders, automated notification system, newsletters, IEP meetings, 504 meetings, RtI meetings, TPC meetings, ESOL meetings, PAC migrant meetings, school council meetings, and PTO meetings. Meetings may be held at various times in the day or virtually to meet parents' needs as needed.

SCHOOL-PARENT COMPACT

South Tattnall Elementary School receives a Title I allocation reserved for parent and family engagement activities. In the spring, parents are given an opportunity to provide input in a survey of how they think the funds should be used for parent and family engagement activities. Parents

are also able to make suggestions to the school at any time throughout the school year and school council meetings. During the Annual Title I Parent Meeting, the school shares ways that the funds have been spent including Parent Institute newsletters, student handbooks, parent communication folders, and supplies for parent and family engagement meetings.

- The District Family Engagement Coordinator communicates and collaborates with local Head Start Programs throughout the year to ensure families are aware of enrollment dates and requirements. The District Family Engagement Coordinator also shares Kindergarten Registration information at Family Connection meetings and upon request from community partners.
- The South Tattnall Elementary School Counselor serves as a resource for parents to obtain literature on hygiene, bullying, nutrition, and other pertinent topics.
- The programs at South Tattnall Elementary School encourage and support parents and families participating in their child's education.
- South Tattnall Elementary School provides a Pre-Kindergarten to Kindergarten transition parent meeting in the spring.
- South Tattnall Elementary School collaborates with South Tattnall Middle School to provide an
 orientation and experience for 5th grade students transitioning to 6th grade in the spring. The
 parents attend a 6th grade orientation at the middle school before school begins.

BUILDING CAPACITY OF PARENTS

<u>South Tattnall Elementary School</u> will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

- Providing parents with a description and explanation of the curriculum in use at the school, the forms of academic assessments used to measure student progress, and the achievement levels of the challenging State academic standards; and

South Tattnall Elementary School provides parents with a description and explanation of the curriculum and assessments in use at the school as well as individual student academic assessment results and interpretation of the results, Title I, Part A requirements, and parent materials and training to support their child's academic progress through multiple participation opportunities. These opportunities include parent-teacher conferences, RtI parent meetings, 504 parent meetings, IEP parent meetings, EIP parent meetings, Annual Title I Parent Meeting, open house, grade nights, literacy night, GMAS assessment information parent night, and Pre-Kindergarten to Kindergarten Transition meeting. South Tattnall Elementary School provides opportunities for the participation of parents with limited English proficiency. ESOL teachers are available to assist students and parents with limited English proficiency. Individual academic assessments and the interpretation of the results will be interpreted for parents in a language they can understand through the assistance of the ESOL teachers and translator as needed. The school also has a Migrant Student Service Provider (SSP).

BUILDING CAPACITY OF SCHOOL STAFF

<u>South Tattnall Elementary School</u> will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

Building capacity of school staff in the value and utility of contributions of parents and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between home and school will be provided by the academic coach through professional development, professional learning communities, and/or grade level meetings. The school responds to parent requests for parent and family engagement activities from the spring survey.
