CALENDAR MEETING

Call to order by Ms. Franco at 6:22 pm. Attendance and roll call was taken. We did not have a quorum. *This meeting is for information only.*

Presenters:

Sharon Rencher: Senior Advisor to the Chancellor/ Senior Executive Director State/Federal Education Policy and School Improvement Programs. Presentation: Every Student Succeeds Act (ESSA) See PowerPoint.

Ms. Rencher gave an update on ESSA. The ESSA law replaced the "No Child Left Behind" law which is no longer in effect. The US government will be using the current ESSA law until Congress makes a decision on revisions. In order to accommodate the public, they will be drafting proposals and presenting it to the public for comments and input. This is a transitional year for this program, but for 2017-2018 the program will be fully operational and effective for the next 10 years. The major programs funded through ESSA that will not affect New York City:

- Title IC: Education of Migratory Children
- · Title V: Rural Schools
- Title VI: Indian, Native Hawaiian, and Alaska Native Education

The minor changes in New York City:

- Title ID: Prevention and Intervention Programs for Children & Youth Who are Neglected, Delinquent and At-Risk (Under this title the funds will be used for D75/D79 programs in NYC.)
- Title II: Preparing, Training and Recruiting High Quality Teachers, Principals and Other School Leaders (Under this title the funds would be used for reducing class size/training teachers & principals.)

Under the Federal Act of ESSA, the state will be giving 3rd grade-8th grade State Assessments Tests for Students and High School Students. The Secretary of Education wants at least 95% of HS students to participate in the State Assessment Tests. If a student chooses to Op-Out of a state test, the student has failed the test. If 5% or more of the students Op-Out of the testing, the school will be penalized, but this does not include excused student absences. The state would list that school as a school in need of comprehensive improvement and support schools list, thereby lowering the schools academic ranking. Even if that school was a high achieving school. Additionally, for the schools on that list, the government would provide additional funding and redirecting monies away from truly under-achieving schools.

Under this new law there is no "Teacher's Evaluation" at the federal level. The states must put in their own "Teacher's Evaluation," if they want federal monies with the "Race to the Top Program."

The Schools in NYC under the list of Priority and Focus schools will be renamed as Comprehensive Improvement Schools. Also the HS with less than 67% graduation rate and performing at the bottom 5% in the state would be listed as a Comprehensive Improvement School. The US Department of Education would like all states to deal with this new program individually.

The federal government wants to use the 4 year graduation rates for HS but the State Regents want to use the 5,6,7 years rate instead.

There will be discussions set up by the DOE in October and November Town Hall Meetings for public comments and input.

Questions by the members:

Ms. Russo: Will the Op-Out testing students be penalized?

Ms. Rencher: No, they will not be individually penalized. The school will be.

Ms. Russo: How would Op-Out testing effect college applications?

Ms. Rencher: For the students who Op-Out, college choices would be limited where there is no grade, and admissions to that college is academically driven.

Ms. Franco: What happens to extend time during testing with students that previously received it?

Ms. Rencher: That would not change, they will continue to receive extended time testing.

Mrs. Gebrail: What would happen to Teacher Evaluation?

Ms. Rencher: Under the Federal level, they will not have Teacher Evaluation, but under the state, they will have Teacher Evaluation.

Contracts for Excellence (C4E) Requirements

Funds must support six specific program areas:

- 1. Class Size Reduction
- 2. Time on Task
- 3. Teacher & Principal Quality Initiatives
- 4. Middle & High School Restructuring
- 5. Full-Day Pre-Kindergarten Programs
- 6. Model Programs for English Language Learners

Funds must go to students with the greatest educational need.

- English Language Learners
- Students in Poverty
- Students with Disabilities
- Students with Low Academic Achievement or At Risk of Not Graduating

Funds must supplement, not supplant.

The State C4E total amount is \$531 million with \$183 million going toward "Schools Fair Student Funding," and \$348million spending under the C4E guidelines. It is also for the continuity of services for existing C4E programs and not for new programs. Some of the DOE proposals for this program: District-wide Initiatives:

- \$15 million to support programs for the needlest students.
- Central programs for HS students: Multiple pathways to Graduation Initiatives, Principal Training Initiatives, College and AP Prep and ELL Youth Institute.

Maintenance of Effort:

• Funds to maintain summer programs of students with the lowest academic achievement. High School Programs:

- Class Size Reduction
- Time On Task: Tutoring (Dedicated and Individualized), Saturday programs, etc.
- HS Restructuring
- Teacher & Principal Quality Initiatives
- Model Programs for ELLs

The deadline for submitting public comments will be November 17, 2016.

President's Report

- Ms. Gebrail attended and volunteered at the Citywide High School Fair at Brooklyn Tech on September 24, and 25 along with Ms. Chandler and Mr. Akram. Many HSs stayed for the whole fair and did not leave early as previously.
- Adam Paredes of HS Enrollment, was very helpful and introduced her to a new HS, "The Urban Assembly School for Emergency Management," who accepts all HS applicants.
- She attended a workshop by Melinda Katz on October 6, 2016 for the Parent Advisory Board on grants, scholarships, HS admissions and other information for parents. At the meeting they gave out conflicting information on the HS admissions.

Member's Report

Ms. Chandler contacted the SCA to follow up on last year's submissions. The SCA said they looked into all the CCHS submissions, not only our priority.

She asked about 4 schools of concern in particular.

East NY Early Family Academy, Brooklyn had poor heating in the main building, no heat in TCU, poor electricity and very old boiler in the main building. SCA will remove the old boiler and will give them a new building due to the removal of the TCU's. SCA plans to remove all old boilers in all the schools due to hazards.

In Francis Lewis HS, Queens, the building has over 100% capacity and have TCU's. They are also working with many schools to remove the TCU's, addressing them individually to resolve problems.

HS Arts and Businesses, Queens have no gym. They are using the school's cafeteria for gym and are making the students cross a major busy highway to use a gym in a neighboring school. The SCA will look into building a gym on top of the school building.

Forest Hills HS, has been under construction for over 6 years and it was supposed to be finished in 1 to 2 years. SCA said upon construction, building plans had to be changed at the last minute and this is delaying construction. Ms. Chandler will follow up with this school.

Ms. Russo attended a CPAC meeting this morning where the Office of Safety and Youth presented on supporting HS students in temporary housing. She would like them to present at a CCHS meeting. She also attended a workshop by IncludeNYC and Parent Leadership Institute. At the Brooklyn HS President's Council meeting parents complained about inaccessible schools for parents with disabilities. Some parents have to use loading docks to get into their schools.

No other members made a report.

Treasurer's Report

Ms. Bajraktarevic read the Treasurer's report. See attached. Ms. Chandler asked questions and had revisions.
