# **CALENDAR MEETING**

Call to order by 1<sup>st</sup> Vice President (Acting President) Ms. Hughley at 6:18 pm.

#### **Program Presentation**

Project Lead The Way Presenter: Glynis O'Leary

Ms. O'Leary said there are currently 19 H.S from the 5 boroughs enrolled in the program. Some of the schools are: HS for Math, Science and Engineering at City College, Brooklyn Technical HS, Manhattan Bridges HS, Bayside HS and Automotive HS. Project Lead The Way even serves the English Language Learners and Special Education students. The basic cost for the school to join is \$3000 for 5 to 5000 students which this non- profit group can help them write grants to fund the cost. There are other costs such as consumer able and hardware such as computers which they will explain to the schools and also tried to help them write grants to offset it in order to bring the program into the school. The school can also use Perkin funds to offset their operating cost of the program.

The principal would send the teachers for a week or two for intensive training and then they will give continual support to the teachers with all the written and software materials. There program does not replace the math or science classes but they enhance what the school curriculum already has. High Schools with CTE programs usually use their program and the classes often replace the Fine Arts credits for HS. At the end of the year the program has assessments and for a fee the students can take a test to recieve college credits from Rochester Institute of Technology which the students can then apply towards college.

<u>Supporting the Homeless High School Students In The Public High Schools</u>

Presenters: <u>Lois Herrera</u> (Deputy CEO for Youth Development and Support Services Office of Safety and Youth Development) and <u>Susana Vilardell</u>, Director of Students in Temporary Housing

The information is on the Department of Education website under: <u>Students in Temporary Housing</u>. It has the "McKinney-Vento Homeless Assistance Act and Chancellor's Regulation A-780 ensure that students residing in temporary living situations have access to the same public education and services that are available to permanently housed students." And "The Students in Temporary Housing (STH) unit within the Office of Safety and Youth Development is available to answer questions on the rights of students residing in temporary housing situations. In addition, STH Content Experts are available in each borough to provide technical assistance and to work directly with schools."

The homeless student enrolls in the school of origin and they get the following: lunch, school supplies, transportation, no documentation needed until 30 days, they have "family assistance in shelters" to help families, 150 shelters in NYC, 40 afterschool programs and 4 programs are in a HS. They partnered with other agencies to help the families and uses the Residency Questionnaires given out at schools to help them identified the homeless or doubled up families.

They try to service the special needs of the students with IEP/ELL with special afterschool programs: 2 in Brooklyn, 1 in Bronx, 1 in Queens in afterschool HS programs.

Under the Title 1 program monies are set aside to provide academic support for homeless students and it's up to the principal to decide to how to spend the monies. They can spend it on uniforms, books or open longer hours for the library. A Title 1 school set aside the minimum of \$100 per STH student and a non - Title 1 school are required to set aside monies as indicated in the Title 1 SAM by borough.

#### **President's Report & Announcements**

Ms. Hughley announced: that there upcoming McKinney-Vento training in Middletown, and there is an IEP certification training in Brooklyn Parent Center, a Latino College Fair on Saturday March 15<sup>th</sup> at NYU. And for the Staten Island vacancy there are 2 new candidates and 3 new candidates for the Bronx vacancy. We will be interviewing them.

### Members Reports

Mr. Kaufman: He attended his 1<sup>st</sup> PEP meeting of the year and the change is dramatic due to the new chancellor. He also attended the CCSE meeting where there are several vacancies.

Ms. Franco: How are we (the CCHS) going to move forward? We need to stop bickering. We need to help our children and help our families. CCHS need to meet with the special education and to have a discussion together about reform. They are still missing a lot of services.

Ms. Russo: She attended the CCELL meeting and talked about how to support ELL HS students. They are still under performing. We just had our Annual Report and Budget committee meeting and she is making a committee report. Ms. Russo is proposing a change by adjusting the Staten Island and the Bronx representative and adjusting the members expenses to \$12,400 and the operating expenses are \$7,600. The difference will go into the report. We agree to have an addendum to the Annual Report.

Mr. Ng: No Report

Ms. Watson: She will be a member of the investigating team from the group "Alliance for Quality Education" whom in 2007, filed a lawsuit for fiscal equity in fair spending on education in the NYC public schools. Some of the schools are over funded by 120% and some are under funded by 80%. She will be a part of the team visiting the schools.

Mr. Cere: He feels the same as Ms. Franco regarding to bickering with emails and in the meetings. The members' energies will be better spent focusing on the needs of children and families.
