

Opening Statement

Saints John and Paul School's plan is a living document. SJP's plan will be updated when changes are made by the CDC, New York State Department of Health, Westchester Department of Heath, Governors Office, New York State Education Department and the Archdiocese of New York. These updates will be posted by date on our <u>SJP</u> website.

This set of slides is to explain SJP's reopened plan according to Archdiocesan Stages.

We are currently in Stage 1, and enacting Options A and B simultaneously. The other options for Stage 1 are contingency plans. The timeline for the other stages will be announced by the Archdiocese (and then communicated to our community if or when we proceed into them).

Saints John and Paul School has the ability to maintain all students with appropriate social distancing, supply protective equipment (PPE) to students, staff, and visitors.

Saints John and Paul will also be in contact with the public school transportation that supplies bussing to our small percentage of students to coordinate with them their protocols for each district. Students and families are instructed to follow the guidelines of the local bus companies that are used for transportation.

Archdiocesan Stage 1 for SJP has the following guidelines:

- No volunteers in the school
- No early drop off or extended day
- Additional mandated services will be coordinated by the parent and school to accommodate our students with IESP or CPSE services via tele therapy.

Stage 1 Options

Option A (Enacted)

In-House Hybrid Full Population:

Saints John and Paul School is a small private school that can accommodate our entire school population five days a week on our existing campus. All classroom space allow for 6' distancing. This is achieved by splitting the classrooms into cohorts. This was also accomplished by converting the gym and the lunchroom into instructional spaces with 6' distancing for our larger classes.

Utilizing our church to accommodate music classes when needed and maintaining 12' distance.

Utilizing our courtyard for gym also allows for the required 12' distance.

The above is accomplished by always taking into account the health and safety of our students.

There will be some classes that will be virtual even with in-house teaching due to limiting the mixing of cohorts (example regular language classes)

Stage 1: Continued

Option B (Enacted)

Students will also have the option to learn remotely from home in Stage 1. Saints John and Paul School understands the choices parents make for their children during these difficult times. If parents choose to keep their child/children at home, Saints John and Paul will have the ability to virtually have students attend their regularly scheduled classes from home.

For full-time remote learning from home, parents must make this choice with the understanding that we prefer that you remain with this option until the end of the quarter. We do understand circumstances do change. Parents must make the request in writing to the principal where it will be reviewed and subject to approval from the school administrators.

Option C (Contigency Plan)

In-House Hybrid partial population: Will allow students to attend school on A and B cycle per week. This would accommodate all our students on an alternating schedule.

This hybrid model will **only** be utilized:

- first week of school to transition students into the school.
 - Group A Last Name Alphabetical A-L, September 9, 2020
 - Group B Last Name Alphabetical M-Z, September 10, 2020

The above break down would enable families to stay together.

- If any emergencies or unforeseen circumstances may occur in the building.

Option D (Contingency Plan)

Remote Learning Only:

If the State or the DOH Mandates Remote Learning

- model will be used if mandated by the state due to the pandemic or DOH.
- mandate for a particular class due to exposure.
- if the school day goes back to normal with regular class sizes, virtual learning will not be an option and all students will be required to attend school in-house.

Archdiocesan Stage 2 for SJP has the following guidelines, if or when we enter this phase:

- All of the above in Stage 1 and including the following:
- After-School Program The afterschool program will be an extension of the school day with the same regulations and guidelines in place for social distancing, face coverings, and limited access to areas outside of the assigned classroom (cohort). After-school programs will not include any sports programs, third-party vendors, clubs, CYO activities and so on.
 - The addition of a limited number of essential volunteers will be permitted if needed, and as long as guidelines are strictly followed.



Archdiocesan Stage 3 for SJP has the following guidelines, if or when we enter this phase

- All of the above in stages 1 & 2 and including the following:
- Mandated services for IESP and CPSE students will have the potential to be delivered in a social distanced school setting should space be possible if allowed by Mamaroneck Public Schools. The potential to continue tele therapy may still exist in Stage 3.
