President's Report & Announcements

Ms. de Kock:

- 1. CTE schools partnered with Medgar Evers College.
- 2. There are lots of co-locations.
- 3. No phased out schools.
- 4. There is a lawsuit with University Neighborhood High School in Manhattan due to the age of building, small class size and overcrowding. Another lawsuit is with August Martin High School in Queens.
- 5. I will be attending a meeting in the Bronx and Queens.

Members Reports

Ms. Hughley: She visited Long Island High School for Capital Plan.

Mr. Ng: He presented the Capital Plan Committee Report on the November 6th meeting. He would like to add to the report that Elizabeth Rose (Chief of Staff, Office of the Deputy Chancellor) attended the Capital Plan meeting. Mr. Ng visited 9 high schools most are 20 to 50 years old. The emails regarding the Capital Plan information went out to all the high school principals along with all the high school superintendents. The responses from the emails should be returning soon.

Mr. Kaufman commented the SCA only gave CCHS 10 priorities schools, but we have 13 seats on the council and the President should have 2 priorities. The SCA should have given us a total of 14 priorities schools; otherwise someone on the council will not get a selection. Mr. Kaufman would like to choose one priority school. Mr. Krongold offered one Staten Island priority school for Mr. Kaufman to choose from. Mr. Ng stated that there are 32 CEC's (they each get 5 priorities schools) all CEC's has a total amount of 160 priorities schools. All the City Councils received 255 priorities schools and the CCHS receives 10 priorities schools. The total amount the SCA collects from the entire city is 425 priorities schools.

Ms. Franco: Visited Clinton H.S. in the Bronx and other co-located schools. She visited 6 schools with the Bronx Federation and will see as many schools as possible. The Bronx Federation, all the Bronx CEC's and the President's Council are all working together to make their priority school selections.

Ms. Russo: She visited Midwood H.S., Goldstein H.S., P-Tech H.S. and plans to attend additional high schools for the Capital Plan.

Mr. Lee: He plans to attend many high schools regarding the Capital Plan and will contact the Chair about his plans.

Mr. Kaufman: He attended the CEC 3 special meeting and Beacon H.S. relocation meeting. There is a great lack of high school seats in Manhattan.

Mr. Krongold: He attended the sub- committee hearing on the Common Core. There were 300 parents at the meeting, trashing the Common Core. I support the Common Core but the DOE can do a better job with the implementation of the Common Core. They will have growing pains.

Public comment

Speaker: Staten Island parent- The Common Core administrators have a lack of knowledge on the Common Core along with the teachers. In the end it's the Parents that have to be responsible

because it's their child. Ms. De Kock said we need to help train the parents. Ms. Franco added that we need to have better outreach and inform the parents regarding the Common Core.
