BUSINESS MEETING

Ms. Green called the meeting to order at 8:44 pm. Attendance and roll call was taken.

President's Report and Members' report

Ms. Stewart reported her concerns for Renewal Schools. Why are some of the schools closing? What are the schools not getting in order to be successful? She has participated in schools walk-though for school closings. She had issues with the PEP process. AA Ms. Chan suggested that she contact Michael Kraft, a CCHS alumni, to assist her in her questions about the process. She will email Mr. Kraft on Ms. Stewart's behalf.

Mr. Martinez said a letter was issued from the Public Advocates' office to all the CEC's and Citywide Councils. He will forward the letter to the council.

Acting President Ms. Green said the following members from the Bronx participated in the HS walk-through at school closures/relocation and PEP meetings: Ms. Robinson, Ms. Baez, Ms. Stewart and herself. She said, "It felt like the Bloomberg years with massive school closures." There were many angry parents at all the PEP meetings. At least 25 schools were proposed for closures and resetting (relocations) but she is happy to announce that 3 schools will be saved, 2 in Queens and 1 in Manhattan. The DOE needs to do a better job by explaining the reasons for closures/ resetting at community meetings. They need to work harder to do a better job because displacing the students from their schools would cause undue hardships for the students and their families.

<u>Discussion of CCHS workshops, topics and dates</u>

Mr. Martinez would like to have 2 workshops for high school students. He would like the topic of resume writing, with interviewing skills and what going to college is really like, with details. He would like to have 2 workshop groups simultaneously, then flip the workshops, so that all the students will have the benefit of the 2 workshops on one day. He proposed to have CCHS provide lunch for the students and DOE to provide metro cards. The maximum amount of high school students we can accommodate is 150 for a Saturday event. He also proposed a possible livestream event.

Ms. Stewart would like to parents to attend with the students. She feels this might be a learning experience for the parents as well as for the students.

Ms. Green and Ms. Stewart would like to have parent engagement workshop on "Home visits with parents by teachers." Workshop for parents informing them on the Curriculum for each HS subject.
